Each year the number of voters for the Reader Rankings has grown, and this year was no exception. In 2013, more than 8,200 lawyers and legal professionals cast ballots in an online survey made up of more than 80 categories across litigation support, consulting and outsourcing, technology, recruiting and staffing, research, accounting, financial services, real estate, mediation and education. Voters had the option of selecting firms listed on the ballot or writing in their favorite firm. Once voting closed, the *NYLJ* team verified that all voters were lawyers or legal professionals.
