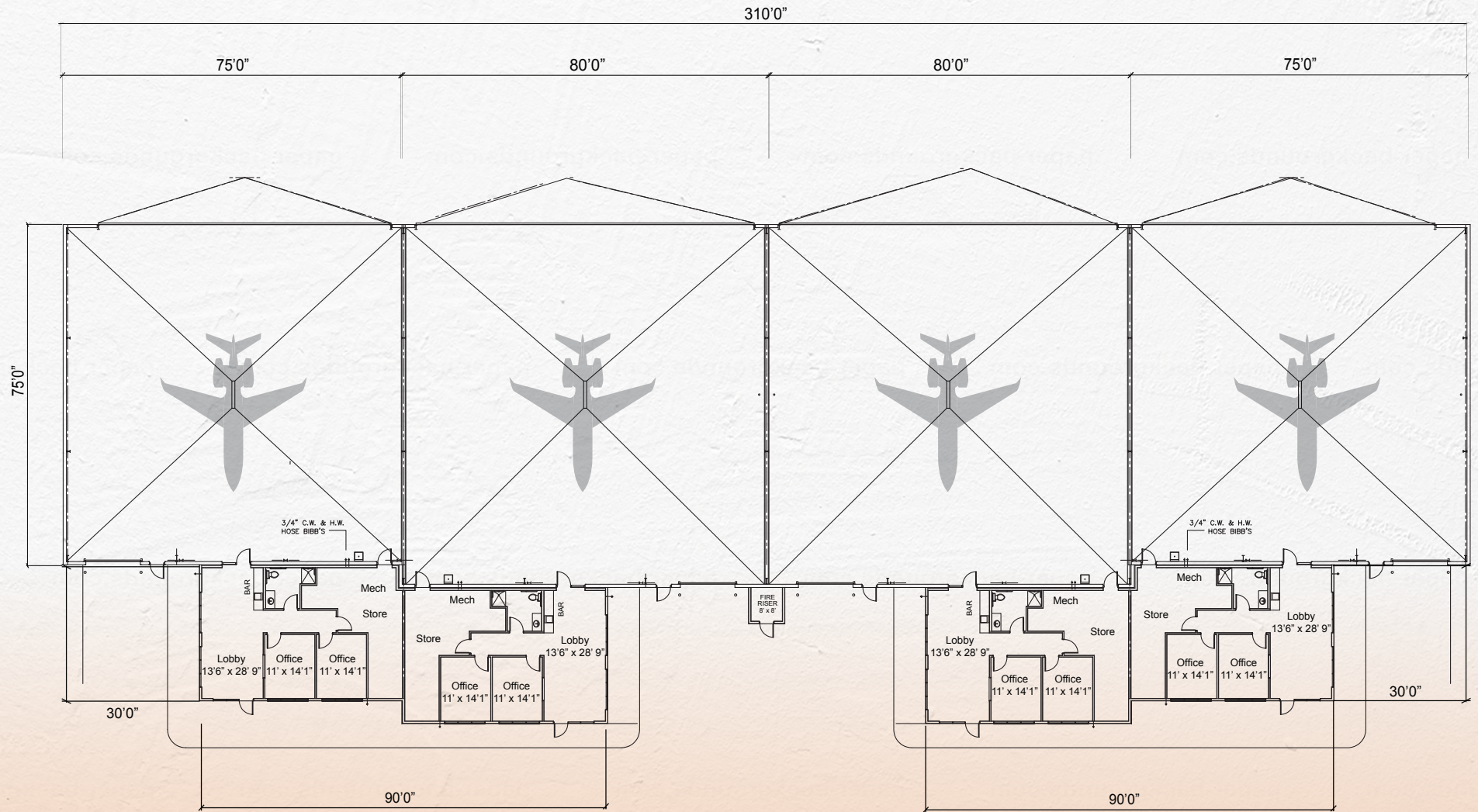
FOUR NEW HANGAR FACILITIES AT COEUR D'ALENE AIRPORT

HIGHLIGHTS

- End hangar units are ±5,625 SF, with 20' tall and 65' wide bi-fold hangar doors
- Middle hangar units are ±6,400 SF, with 24' tall and 75' wide bi-fold hangar doors
- Each hangar has an adjacent 1,320 SF office suite that can be customized
- Insulated and heated hangar and office space
- The developer has secured a 50-year ground lease from the airport for this hangar development, and parties will be acquiring a long-term leasehold interest
- Only 25 miles from Spokane International Airport

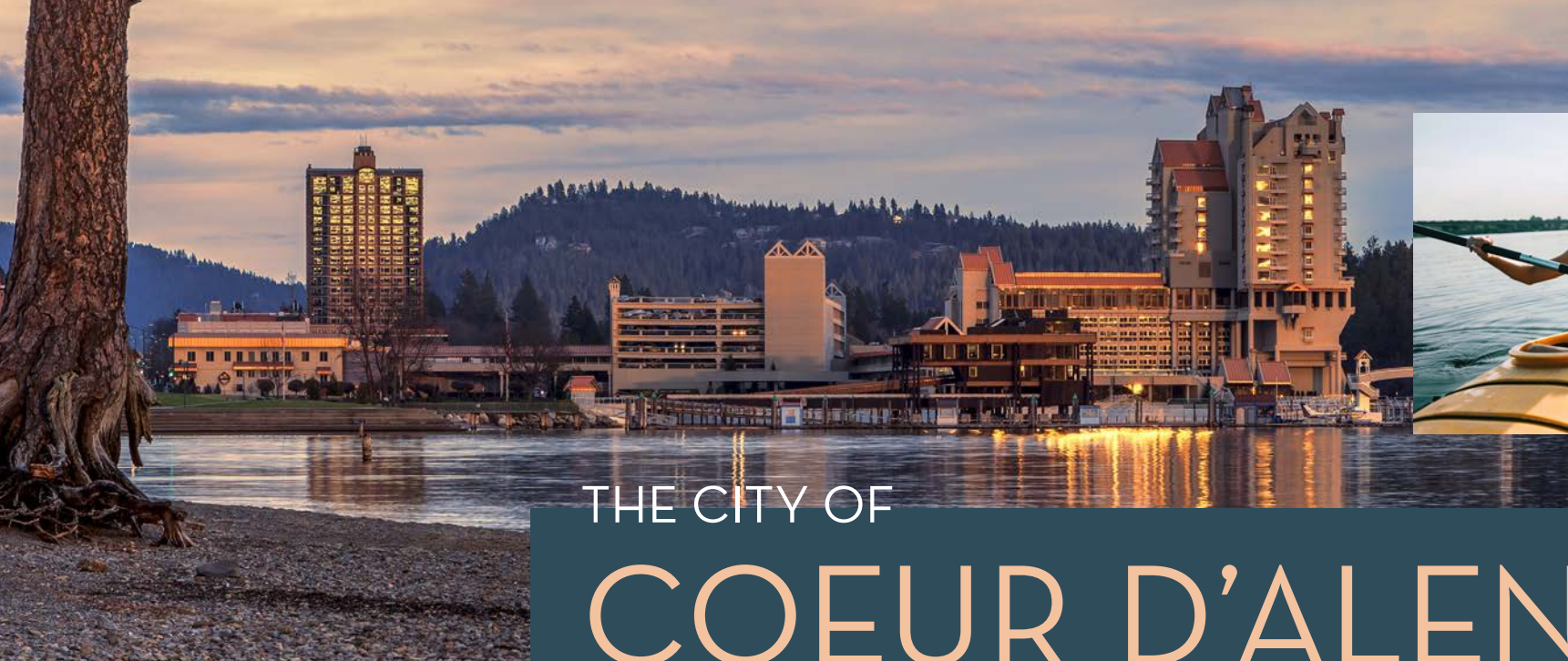

The Coeur d'Alene Airport (Pappy Boyington Field) is a county-owned public-use airport, located in Kootenai County, Idaho. It is located just nine miles northwest of the central business district of Coeur d'Alene and is surrounded by the city of Hayden on three sides. The airport has two asphalt paved runways: 6/24 measuring 7,400 ft × 100 ft and 2/20 measuring 5,400 ft × 75 ft.
